2024 CSC Awards Competition

Rules & Regulations for the Craftsperson Technical Award of Merit Open to both CSC members & non-members residing in Canada

Qualifications: Any individual proposed for this special recognition must:

- be a working professional in their current capacity for a minimum of four years
- display exceptional skill, dedication and professionalism in the performance of their craft
- be either a Canadian citizen or a resident of Canada, AND

Procedure:

1. Must be proposed for this competition by a cinematographer for whom they have worked. It is not required that the proposing cinematographer be a member of the CSC.
2. Each of the accepted prospective nominees will be advised that they have been entered. If they agree to remain in the competition, they are required to provide a résumé listing all cinematographers for whom they have recently worked.
3. A confidential jury of full CSC members will review the résumés to select the one individual to receive the Award.
4. The award recipient will be acknowledged in the program for the annual Awards celebration at which the Craftsperson Technical Award of Merit will be presented to the winner.
